

GOVERNING BOARD OF THE GLOBAL HEALTH EDCTP3 JOINT UNDERTAKING DECISION N° GB/32/2023 ON THE ADOPTION OF THE FIRST AMENDMENT OF THE GLOBAL HEALTH EDCTP3 JU ANNUAL BUDGET 2023

THE GOVERNING BOARD OF THE GLOBAL HEALTH EDCTP3 JOINT UNDERTAKING,

Having regard to Council Regulation (EU) No 2021/2085 of 19 November 2021 establishing the Joint Undertakings under Horizon Europe, and in particular Article 17(f) and (k) thereof;

Having regard to the Financial rules of the Global Health EDCTP3 Joint Undertaking (GH-EDCTP3-GB/22/2022) and in particular Article 12 thereof;

Having regard to the Decision of Global Health EDCTP3 Governing Board (GH-EDCTP3-GB/5/2023) approving the Global Health EDCTP3 Joint Undertaking's Annual Budget 2023 included in the Annual Work Programme 2023.

WHEREAS

- 1) The financial year shall run from 1 January to 31 December;
- 2) The Annual Budget for year 2023 was adopted by the Global Health EDCTP3 Governing Board on 3 April 2023, per Decision GH-EDCTP3-GB/05/2023 "Annual Work Programme 2023 and Annex I (call topics) and Annex II (IKAAs)", pages 20-22;
- 3) In the context of the preparation for the Global Health EDCTP3 JU's financial autonomy in ABAC scheduled for 23 November 2023, official Note 11 from Global Health EDCTP3 JU to European Commission's responsible services (DG RTD) includes Annex 1 (budget lines, budget figures, consumption and net remaining amounts) together with Annex 11 (transfer of file functionality in ABAC workflow and destination budget position in Global Health EDCTP3 JU).

In view of this, the *Statement of Expenditure* of the Annual Budget 2023 shall be amended for the first time in order to make a transfer of both commitment and payment appropriations of EUR 190,000 from line "Meeting expenses" (under Title 2) to line "External services" (under Title 1) in order to ensure enough appropriations in the destination budget lines of the Global Health EDCTP3 JU for commitments level 2 position.

Furthermore, a total of EUR 2,923,466 of both commitment and payment appropriations shall be transferred from administrative expenditure for running costs Titles 1 and 2 to operational expenditure Title 3. This transfer is made since the administrative expenditure was lower than budgeted and the extra appropriations being transferred allow additional proposals from the reserve list to be mobilised for topics, where the response to the calls was large and the success rate low.

To arrive at this transfer, a number of positions in Titles 1 and 2 are lowered in expenditure (salaries & allowances for establishment plan posts, information, communication technology and data processing, meeting expenses, running costs in connection with operational activities and service contracts).

Consequently, the total <u>staff expenditure</u> (<u>Title 1</u>) is amended to <u>EUR 1,831,800</u> and the total <u>infrastructure and operating expenditure</u> (<u>Title 2</u>) amended to <u>EUR 904,734</u>, with the total <u>administrative expenditure</u> (<u>Titles 1 and 2</u>) being amended to <u>EUR 2,736,534</u>. The <u>operational expenditure is amended to EUR 134,820,778</u>. **This represents a total transfer of EUR 2,923,466** from administrative to operational expenditure for the year 2023.

The Statement of Revenue of the Annual Budget 2023 remains unchanged.

4) A Governing Board decision amending the Annual Budget 2023 is necessary, since the transfer of 48% of the original appropriation of Title 1 to Title 3 and of 57.7% of the original appropriation from Title 2 to Title 3 (i.e. EUR 1,687,569 and EUR 1,235,897, respectively) is more than 10 %, of the appropriations for the year shown on the line from which the transfer is made.

HAS ADOPTED THE FOLLOWING DECISION:

Sole Article

The Statement of Expenditure of the Joint Undertaking's Budget for year 2023, as amended for the first time and as annexed to this Decision, is hereby adopted.

This Decision shall enter into force on the date of its adoption.
