

GOVERNING BOARD OF THE GLOBAL HEALTH EDCTP3 JOINT UNDERTAKING DECISION N° GB/43/2023 ON THE ADOPTION OF THE SECOND AMENDMENT TO THE GLOBAL HEALTH EDCTP3 JU ANNUAL BUDGET 2023

THE GOVERNING BOARD OF THE GLOBAL HEALTH EDCTP3 JOINT UNDERTAKING,

Having regard to Council Regulation (EU) No 2021/2085 of 19 November 2021 establishing the Joint Undertakings under Horizon Europe, and in particular Article 17(f) and (k) thereof;

Having regard to the Financial Rules of the Global Health EDCTP3 Joint Undertaking (GH-EDCTP3-GB/22/2022) and in particular Article 12 thereof;

Having regard to the Decision of Global Health EDCTP3 Governing Board (GH-EDCTP3-GB/32/2023) on the adoption of the first amendment of the Global Health EDCTP3 Joint Undertaking's Annual Budget 2023;

Having regard to the Decision of Global Health EDCTP3 Executive Director (GH-EDCTP3-ED/28/2023) related to budgetary transfers between budget lines under Title 2;

WHEREAS

- 1) The financial year runs from 1 January to 31 December;
- 2) The Annual Budget for year 2023 was adopted by the Global Health EDCTP3 Governing Board on 3 April 2023, per Decision GH-EDCTP3-GB/05/2023 "Annual Work Programme 2023 and Annex I (call topics) and Annex II (IKAAs)", pages 20-22;
- 3) The Annual Budget for year 2023 was amended for the first time on 21 November 2023, per Decision GH-EDCTP3-GB/32/2023;
- 4) The total amount of commitment appropriations for both administrative and operational expenditure remains the same. However, due to technical and administrative issues linked to the transfer of files from the European Commission to the Global Health EDCTP3 Joint Undertaking in the accounting system (ABAC) in connection with the process of financial autonomy, the amount of payment appropriations for operational expenditure in the Annual Budget for year 2023 needs to be decreased.
- 5) No change is brought to the statement of revenue of the Annual Budget 2023 or any other part of the 2023 Work Programme.

HAS ADOPTED THE FOLLOWING DECISION:

Article 1

The Joint Undertaking's Annual Budget for year 2023, as amended for the second time and as annexed to this Decision, is hereby adopted.

Article 2

Governing Board decision GH-EDCTP3-GB/32/2023 is repealed and replaced by this Decision.

Article 3

This Decision shall enter into force on the date of its adoption.
