DECISION N° GB/11/2024
Approving the actions selected for funding from the
Mobilisation of Emergency funding for Mpox outbreak research response
(HORIZON-JU-GH-EDCTP3-2024-Mpox) call for proposals

THE GOVERNING BOARD OF THE GLOBAL HEALTH EDCTP3 JOINT UNDERTAKING (hereafter “Global Health EDCTP3 JU”),

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Council Regulation (EU) No 2021/2085 of 19 November 2021 establishing the Joint Undertakings under Horizon Europe and repealing Regulations (EC) No 219/2007, (EU) No 557/2014, (EU) No 558/2014, (EU) No 559/2014, (EU) No 560/2014, (EU) No 561/2014 and (EU) No 642/2014 (hereafter “the Founding Regulation”), in particular Articles 17(2)(u) and 19 (4) (j) thereof,

WHEREAS:

- (1) The Governing Board had approved the Work Programme of the Global Health EDCTP3 JU including the topic for the “Mobilisation of research funds in case of Public Health Emergencies” with Decision GB/05/2023.
- (2) On Friday 26 April 2024, the Executive Director proposed to the Governing Board the activation of the emergency funding mechanism as a response to the current Mpox outbreak in the Democratic Republic of Congo (DRC) and requested its approval (internal ref.: Ares(2024)3084050).
- (3) The call for proposals HORIZON-JU-GH-EDCTP3-2024-Mpox was published on the Funding & Tenders opportunities portal of the European Commission on 30 April 2024. The call opened for submission of proposals on 14 May 2024 and closed on 29 May 2024.
- (4) The evaluation using independent experts according to the Horizon Europe process as defined in the Horizon Europe regulation was concluded on 18 June 2024. The ranking and as relevant the reserve list are proposed for the topic under the HORIZON-JU-GH-EDCTP3-2024-Mpox call for proposals.

HAS ADOPTED THIS DECISION:

Article 1

The results of the evaluation and the actions selected for funding for the topic under the HORIZON-JU-GH-EDCTP3-2024-Mpox call for proposals as shown in the table in Annex are hereby approved.

Article 2

This Decision shall enter into force on the day of its adoption.
