THE GOVERNING BOARD OF THE GLOBAL HEALTH EDCTP3 JOINT UNDERTAKING (hereafter “Global Health EDCTP3 JU”),

Having regard to Council Regulation (EU) No 2021/2085 of 19 November 2021 establishing the Joint Undertakings under Horizon Europe and repealing Regulations (EC) No 219/2007, (EU) No 557/2014, (EU) No 558/2014, (EU) No 559/2014, (EU) No 560/2014, (EU) No 561/2014 and (EU) No 642/2014 (hereafter “the Founding Regulation”), in particular Articles 16 and 17 thereof,

Having regard to the Rules of Procedure of the Governing Board of the Global Health EDCTP3 JU¹ and in particular Articles 4 and 6 thereof,

WHEREAS:

- (1) On 29 May 2024, on behalf of the Chairperson of the Governing Board of the Global Health EDCTP3 JU, the Executive Director sent to the members a written notification convening the seventh meeting of the Governing Board to be held on 27 June 2024 in hybrid mode (at the JU seat in Brussels and online), accompanied by the provisional agenda and the relevant documents for decision-making.
- (2) On 17 June 2024, on behalf of the Chairperson of the Governing Board of the Global Health EDCTP3 JU, the Executive Director sent the final agenda to the Governing Board members.

HAS ADOPTED THIS DECISION:
